Notes for your safety



Personal protective equipment (PPE) must be worn in many areas of our site. For your own safety you must wear the appropriate safety equipment when entering these areas. If you do not have the required PPE please inform your Fronius contact person. Comply with mandatory and prohibition signs. If you have questions ask your contact person.



Electromagnetic fields are present in certain areas.

The access to these areas is forbidden to persons with pacemakers or other implants.



Pay attention to internal traffic when walking on logistics routes and in the outdoor areas. Our forklift trucks are equipped with electric drives, so they may not be heard and generally have priority. Automated guided vehicles (AGVs) project a blue spot on the ground while driving to indicate the direction of travel and increase awareness. Do not loiter in transfer areas. Pay attention to audible and visual warning signals.



On the whole site you must comply with the Austrian Road Traffic Act (StVO) and with the mandatory speed limit.



Smoking is prohibited across all our sites, except in intended outdoor areas or atria.

Ask your contact person before leaving the visitor group.





Do not enter forbidden areas.

Action in case of emergency



Observe alarm signals and instructions of the fire protection team. An audible siren signal means that the fire alarm system has been activated and serves to alert the fire protection team. A continuous siren signal is an evacuation alarm, which means that you must leave the building immediately and go to one of the designated assembly points.



In case of accident or environmental damage, notify our internal on-call service on 0664 6213800. In case of imminent danger, call the emergency services by dialing 122 (Fire), 133 (Police), or 144 (Ambulance).

If there is a fire, alert the fire department by pressing the pushbutton alarms.



In case of danger, leave the building via the escape and rescue routes. Help injured persons. Do not use elevators and close doors behind you. Follow the instructions of Fronius personnel.



Then go to one of the signposted assembly points and await further instructions there. Report missing persons to the Fronius "Emergency Guides" at the assembly point.



In case of injury, first aid kits and first responders are available during working hours.



All Fronius sites are equipped with defibrillators which can be used by non-medical personnel.

Some areas are equipped with a gas extinguishing system.

In the event of an alarm indicated by an audible and visual warning signal, leave the room immediately.



Process for the Fronius contact person
